	<p>The minutes of the last meeting were considered with matters arising:</p> <ul style="list-style-type: none"> <li>Retreat – since we could not meet in 2010, the meeting agreed a date for the 2011 retreat at Ashburnham (8 – 10 April 2011) LR to book date with the centre, send the cost to fellowship co-ordinators. Transportation, logistics, programme and guest speakers will be sorted soonest</li> <li>The meeting requested LR to follow up existing contacts in the Boroughs to confirm the number that is still thriving</li> <li>Communication to the Boroughs should still go through LR for proper monitoring</li> <li>MP to prepare a table of Regional Co-ordinators who will have the responsibility of contacting the Boroughs and report to LR.</li> </ul>	<b>MP</b>

	<p>SN presented a report on LCCN funding and management of account. SN prepared the report with Estell Richards.</p> <ul style="list-style-type: none"> <li>The meeting reiterated the essence of the £1 per month per member and the need to remit to the account.</li> <li>The meeting agreed that £1 is guideline and not a rule. 	<p>The meeting agreed that late February/early March there will be a Borough wide fellowship to be hosted by Haringey Council. It will be on a week day, arrival from 5.30pm. 5	<b>PRESENTATION OF REPORT</b>	
	<p>LR and BG represented LCCN at the Workplace Conference in Portsmouth, 13<sup>th</sup> Nov 2010. The conference was organised by Transform Work UK.</p> <p>BG presented a report on the conference encouraging everyone that the workplace ministry is about life bearing in mind the number of hours we spend at work.</p> <p>Among other speakers and seminars attended on the day, she said the presentation by Chan Abraham, CEO Luminus Group, was insightful. He spoke on 'Faith, Work, and Victory'. Some quotable quotes from the paper include:</p> <ul style="list-style-type: none"> <li>'Be a steel hand in velvet glove'</li> <li>'Live in such a way that you will not be ashamed to sell your parrot to the town gossip.'</li> <li>'You must be involved if you want to see the change'</li> <li>'We are ordinary people doing extraordinary things through Him'</li> </ul> <p>Mr Abraham is reputed to be running the company on Biblical principles with testimonies attending.</p> <p>LR &amp; BG advised that he is a potential guest/speaker at any of LCCN retreat or meeting and we should invite him at the appropriate time.</p> <p>On the next conference, sometimes this year, MP suggested that LCCN should participate as facilitators. The meeting agreed that LCCN should take the lead for a conference in London in conjunction with other workplace fellowships.
